1. Eligibility

You must be at least 18 years old to use the App. By registering, you represent that you are of legal age and have the authority to enter into this agreement.

2. Purpose of the App

Axon Wave is intended for educational, observational, and research use only. The App allows users to upload EEG data files (EDF format), generate qEEG-style visualizations, and store files for later review. The App is not a medical device, does not provide diagnosis or treatment, and is not approved by the U.S. Food and Drug Administration (FDA).

3. Account Registration

To use Axon Wave, you must create an account and provide accurate, complete information. You are responsible for maintaining the confidentiality of your login credentials and for all activity under your account.

4. Permitted Use

You agree to use the App only for lawful, non-commercial purposes and in accordance with these Terms.

You may not:

- Upload content containing PHI, patient names, or identifiable clinical data
- Use the App for diagnosis, treatment, or medical advice
- Attempt to reverse engineer, copy, or interfere with the App's functionality
- Access another user's account without permission
